

## Bollinger Hills Homeowners Association

### Swimming Pool Rules

1. If a lifeguard is not present at the swimming pool NO CHILD 14 YEARS OF AGE or younger is allowed in the pool or pool area without the supervision of an adult. An adult for Bollinger Hills Homeowners Association is someone over the age of 21.
2. When a lifeguard is present, NO CHILD UNDER THE AGE OF 8 may be present without the supervision of an adult. An adult for Bollinger Hills Homeowners Association is someone over the age of 21.
3. No use of the equipment, which is the exclusive property of either Bollinger Hills Homeowners Association or the lifeguards.
4. Radios, CD Players, etc. must be kept at a personal listening level.
5. Pool closes at 10:00 PM, seven days a week.
6. During Lifeguard breaks ONLY adults (anyone 18 years or older) may swim. If the lifeguard is unsure of your age, you must be prepared to present ID.
7. Everyone MUST SHOWER at the pool prior to swimming.
8. No diapers allowed in the pool except approved swim diapers.
9. No pets, skates, skateboards, scooters or bikes inside the pool area.
10. No running, roughhousing or horseplay in pool or pool area.
11. No diving in shallow end of pool.
12. No glass containers in pool or pool area.
13. No smoking in the pool area
14. No large floats in pool.
15. No swearing, splashing of others who do not wish to be splashed, yelling in kid's ears, disrespect for lifeguards, etc.

16. Lifeguards have final authority to enforce all rules and issue directives to deal with all situations while present whether or not officially on duty. Lifeguard orders must be obeyed immediately even if disputed.

1<sup>st</sup>. Offense – Banned from the pool for the day with phone call to parents.

2<sup>nd</sup> Offense – Banned from the pool 1 week with call and letter to parents.

3<sup>rd</sup> Offense – Banned from the pool for the rest of the season
